GROWING WITH YOU

The concept of “community action” emerged as part of the War on Poverty Program introduced through the Economic Opportunity Act of 1964. The goal of Community Action focused on helping individuals achieve self-sufficiency by providing necessary resources.

South Plains Community Action Association, Inc. (SPCAA), originally established in November 1965 as Hockley County Community Action Committee, Incorporated, was chartered as a non-profit organization based in Levelland, Texas. Over time, the agency gained recognition throughout its service communities. Its foundation rested on the principle of people helping people, encapsulated in its Mission Statement, “Helping People. Changing Lives.”

On July 1, 1970, the organization formally adopted the name South Plains Community Action Association, Incorporated. From its beginnings in Hockley County, SPCAA has remained committed to its mission and expanded its efforts to provide opportunities, resources, and new initiatives. These offerings aim to support families, children, the elderly, and individuals with unique challenges in progressing toward economic growth and self-sufficiency.

Currently, SPCAA continues to uphold its mission, which has guided its work for 59 years. The agency has experienced significant growth, evolving from a \$4 million organization to an impressive \$70 million operation that serves 114 counties. SPCAA's programs are executed through funded service contracts and are delivered in selected communities based on the availability of these contracts.

The Fiscal Department consist of 15 staff managing budgets, purchasing, and reporting for approximately 75 individual funding streams at any one time throughout the year.

HUMAN RESOURCES

Human Resources transitioned to a paperless and virtual space for all new employee files, and will continue to create digital files for current employees. With close to 200 new hires and 600 active employees, the process is a major undertaking, but staff know the benefits of completing the process. SPCAA transitioned to Curative for health insurance January 1, 2025, for a major rebranding and great opportunity for the agency and staff. In addition to the premiums decreasing for the agency, staff were welcomed with a \$0 copay, \$0 deductibles, and \$0 out of pocket expenses for employees and any dependent on the plan, with a call to a health coach/provider with Curative. This is not only a shift in the healthcare space models, but an opportunity for staff to receive the healthcare needed with no financial limitations or restrictions. Curative is new to the West Texas area, and employees have provided very positive feedback early in the transition. We will continue to monitor the healthcare transition and remain focused on staff benefits and salaries to ensure SPCAA recruits and retains the best staff.

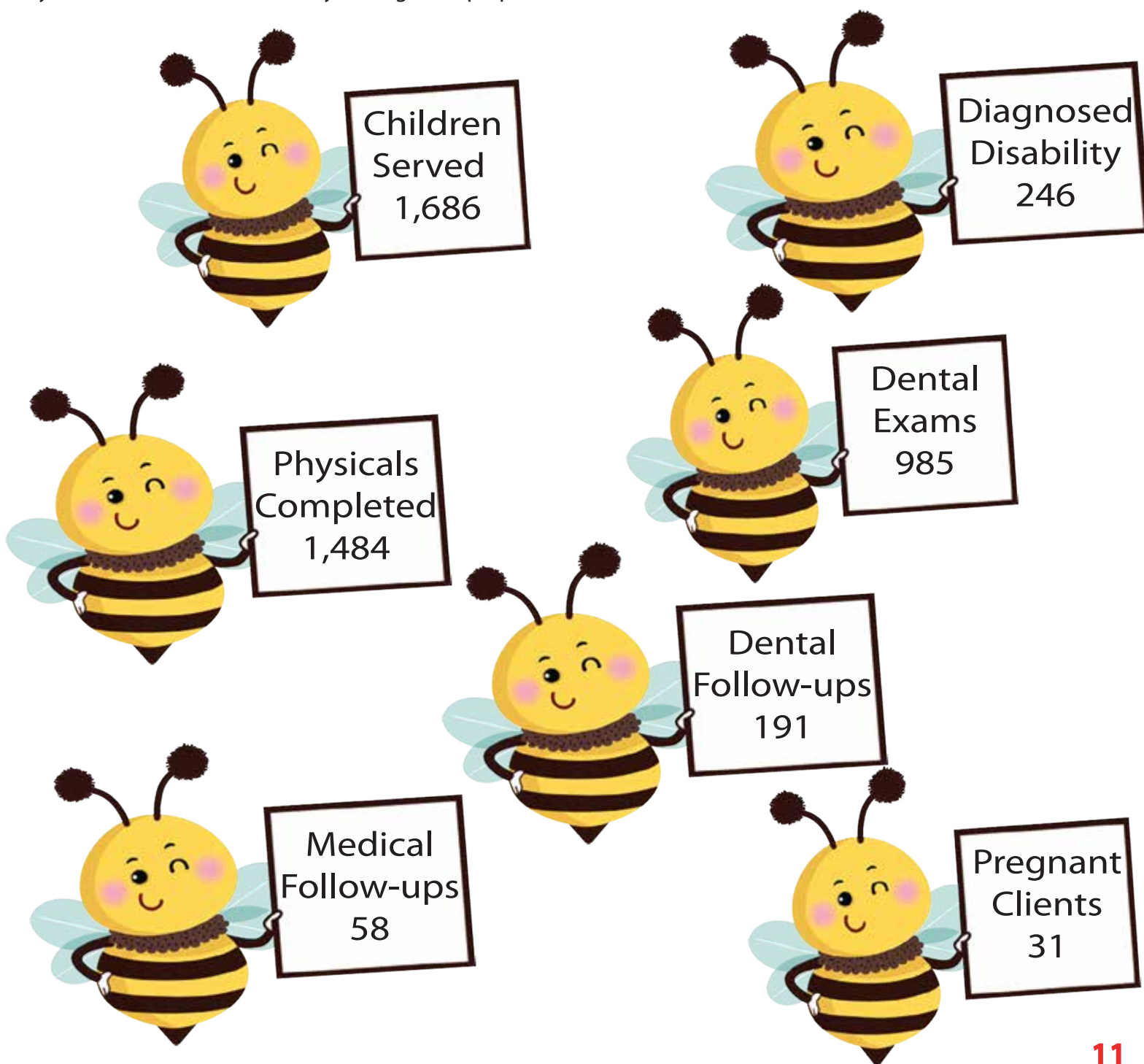

HEAD START AND EARLY HEAD START PROGRAMS

Head Start and Early Head Start programs promote the school readiness of preschool-aged children, infants, toddlers, and service for pregnant women. Head Start and Early Head Start programs support children's growth from birth to age 5 through services that support early learning and development, health, and family well-being. Early Head Start focuses on families with children ages birth to 3 years of age, and may also serve expectant families. These services are available at no cost to children ages birth to age 5 in eligible families. These two programs deliver child development services in center-based, home-based and family child care settings. All Head Start and Early Head Start programs continually work towards the mission of helping children and families receive high-quality services in a safe and healthy settings that prepare children for school and life.



PANWEST TX NAVIGATOR CONSORTIUM PROGRAM



SPCAA leads a 3-part organization consortium called the PanWest TX Navigator Program as the direct federal grantee of the project with Panhandle Community Services and Project Amistad as its subgrantees to cover 94 counties of the South Plains, the Concho Valley, the Panhandle, West Central Texas, and far West Texas. The Navigator Program has trained and certified staff who assist individuals apply for and enroll into insurance through the Health Insurance Marketplace. Navigator staff also provide education and outreach on the Affordable Care Act and available Marketplace Plans within the service region.

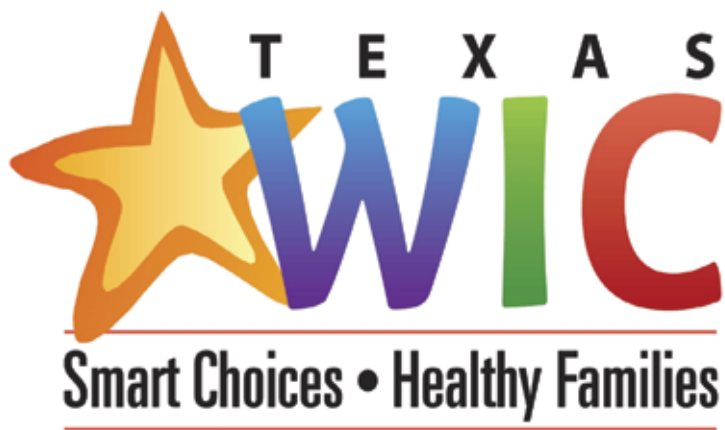

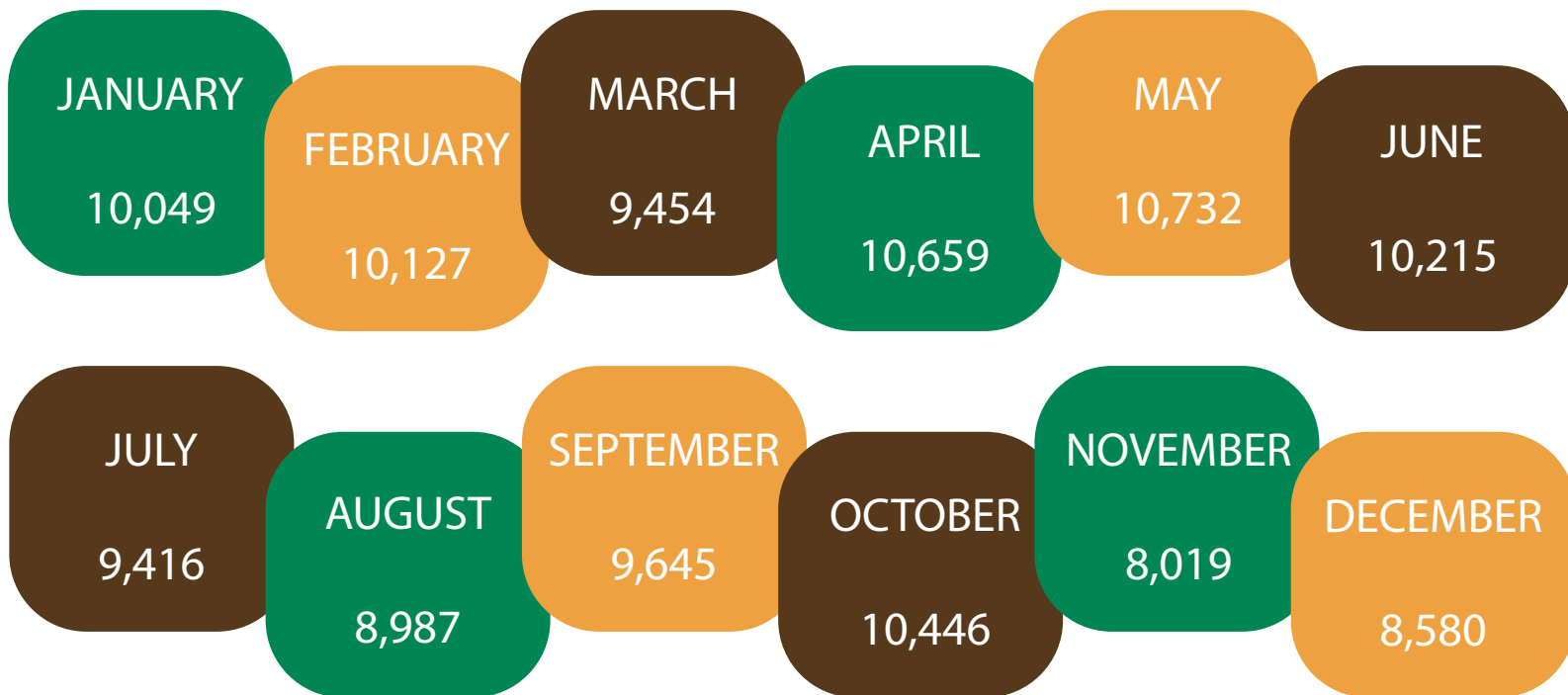

Ms. Sandra Cavazos is a single person in her home. Sandra was unemployed when she first came to see about assistance back in February 2024. I decided to enroll Sandra in case management which she agreed to all terms. Sandra was then assisted through the CEAP Energy Assistance Program. Later in time, I was able to request CSBG Direct Assistance for a food gift card through our CSBG Coordinator Christy Vargas. Sandra was very limited in resources and the food card would be beneficial. Sandra attended our Correctional Officer Hiring Event in July 2024 to try and apply for any job openings that she would qualify for. Sandra did not have to wait to hear from them, she had also done other job applications and was called to work remotely with a company called Group O Incorporated. Sandra was hired and works from home and with all the training, she was later able to receive an increase in pay bringing her income over the 125% poverty level. The case management follow-ups for Sandra showed the first time she went over 125% and then followed by the 30/60/90 days to show she was able to successfully complete the case management program and achieve goals to become self-sufficient.

SUCCESS STORIES

Ruben and Laura Ramirez came in seeking utility assistance April 2024. They both had been unemployed for awhile and in a tough spot. Laura was able to obtain work at a local convenience store, while Ruben search for a job. Ruben wanted a better life and decided to quit his previous job to try and go school full-time for his CDL. He expressed he didn't want to be away from his family and the current program he had applied with required him to sign a 12-month contract to work out of state doing long truck haul. Our local Service Specialist - Olga Reyna from Matador spoke with him about the case management program and he was extremely excited to enroll and get started. SPCAA partnered up with the WIOA program and registered Ruben for classes, helped him in getting his physical and driving permit along with setting him up for his testing dates. Unfortunately, after a few attempts at testing to get a permit, Ruben was unable to pass. He got discouraged, but staff persisted and gave him other options through WIOA who offered support for those unable to pass, but he refused because of being disappointed with himself. During this entire process of working with Ruben, his wife Laura was excelling at her job. Laura received a raise within a few months of work and was promoted to store manager and then later on received another raise and started receiving supervisor monthly bonuses. By June, they were 125% poverty level and doing great! Ruben was able to get a job at the same store and kept his job for at least 90 days and surpassed his goals and still has that same store job. The Ramirez bought their first home and moved at the end of November, just in time for the Thanksgiving holidays. After completing the case management program, the Ramirez were at a poverty level of 160.95%, well above the 125% poverty level. They were grateful for the program for all the help and support given to them during their time of need.



After facing many obstacles, Ruben & Laura Ramirez from Crosby County were both able to obtain and maintain employment for 90 days, which allowed them to Transition Out of Poverty. They purchased their first home in November 2024.

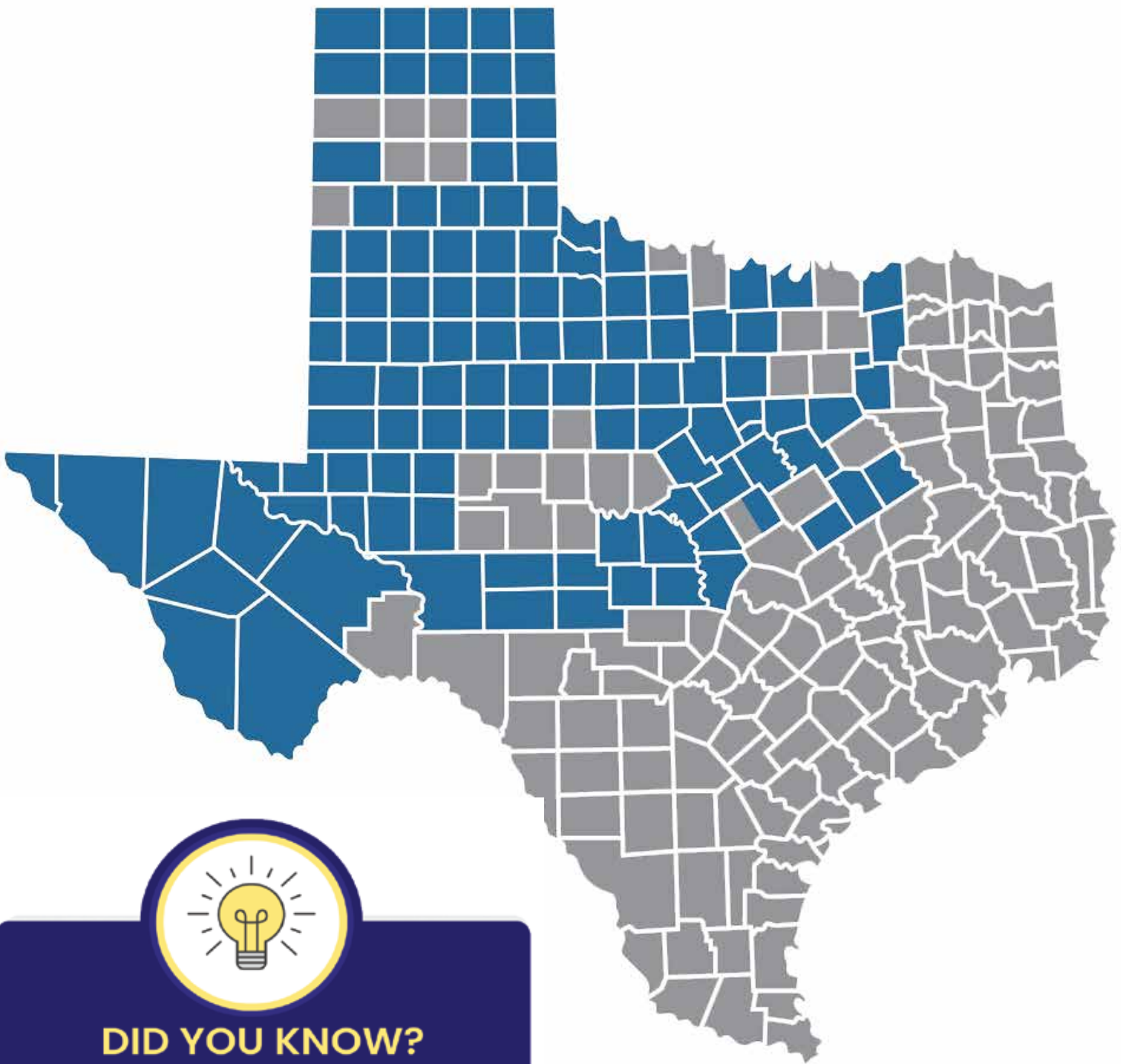
