#### **Request for Proposal for Access Control Systems and Ongoing Support**

#### **Background Information**

South Plains Community Action Association, Inc. (SPCAA) is a 501(c)3 non-profit corporation headquartered in Levelland, Texas. SPCAA is a designated Community Action Agency funded in part by the United States Department of Health and Human Services' Community Services Block Grant Program. SPCAA currently administers approximately 64 grant-funded programs in a 126-county area across Texas, including core services in Bailey, Cochran, Crosby, Dickens, Floyd, Garza, Hale, Hockley, King, Lamb, Lubbock, Lynn, Motley, Terry, and Yoakum Counties.

The agency administers grant funded programs in seven program divisions – Community Services, Child Care Services, Head Start/Early Head Start, Health Services, Housing, SPARTAN Transportation, and Workforce.

#### **Facility Door System Needs**

South Plains Community Action currently uses the Premisys access control system at 32 locations on 93 total door/keypads, throughout the South Plains area. See Attachment 1 for an itemized listing of addresses and currently owned infrastructure.

#### **General Specifications**

#### A. Request

SPCAA is requesting proposals from qualified vendors to recommend access control system upgrades to replace the current system, which will soon be obsolete. SPCAA understands that proposals may include the purchase of new infrastructure (control boards, etc.), or that proposals may recommend repurposing existing infrastructure. Bidders should contact Jory Stockard to schedule onsite visits as needed during the bidding process to assess the current system.

SPCAA also seeks pricing for the ongoing maintenance and support of the access control system, whether provided on a monthly or annual basis. Bidders are asked to provide current rates for service calls.

#### **B.** Contact Person

#### C. Questions

All questions concerning this RFP packet should be directed to the email address shown above. Questions must be received by August 18, 2025, at 12:00 pm Central time to receive a response. A summary of all questions and responses will be made available on the agency's website (https://www.spcaa.org/news-and-events).

#### D. Submittal Requirements

Proposals are to be submitted in compliance with the specifications contained in this RFP; SPCAA will expect strict adherence to these specifications. Any limitations or deviations from these specifications must be designated in the proposal. This RFP and the selected proposer's response will be included in the final contract.

Due care and diligence have been used in the preparation of these specifications, and the information contained herein is believed to be substantially correct. SPCAA and its representatives will not be responsible for any errors or omissions in this procurement document or for the failure on the part of the proposer to determine the full extent and scope of the services required.

#### E. Deadline for Submission

The deadline for submission is 12:00 pm Central Time, September 8, 2025. Proposals must be submitted electronically at the email address shown above. Hard copies will not be accepted.

#### F. Timeline

The successful bidder agrees to become the contracted service provider for SPCAA access controls systems beginning October 1, 2025. Onsite system upgrades will be handled on a case-by-case basis in coordination with SPCAA I/T staff.

#### G. Limitations and Reservations

SPCAA reserves the right to accept or reject any and all proposals received as a result of this request, to negotiate with all qualified sources, or to cancel in part or in its entirety this RFP, if found to be in the best interests of SPCAA.

This RFP does not commit SPCAA to award a contract, to pay any costs incurred for preparation of proposals, or to procure or contract for any services.

SPCAA specifically reserves the right to vary the provisions set forth herein any time prior to the execution of a contract where such variance is deemed to be in the best interest of the needs of SPCAA.

If selected for contractual negotiations, proposer may be required to prepare and submit additional information prior to final contract execution, in order to reach terms for the provision of services, which are agreeable to both parties.

#### H. Modifications and Renewals

SPCAA intends to award a one-year contract, with the possibility of annual renewals as determined based on performance and software upgrades and SPCAA needs. Contract modification and renewals shall be considered based upon the service provider's ability to meet SPCAA's needs.

#### I. Signatures

The form Certification of Compliance with Specifications must be signed by the authorized official. It shall be understood that a signed proposal is a firm bid for a ninety (90) day period from the date the proposal is received by SPCAA. The proposal shall also provide the name, title, address, and telephone number of the individual(s) with authority to negotiate during the period of proposal evaluation.

#### J. Evaluation Criteria

Each proposal will be evaluated in accordance with the weighted evaluation criteria shown on the Proposal Evaluation Table (page 13); this worksheet will be used by SPCAA's independent evaluation committee. The factors total 100 points; proposals with scores of less than sixty points will not be considered. Scores will be used to develop a list of potential service providers with whom negotiations may be conducted.

#### **K.** Protest Rights

All protests or complaints regarding this RFP process shall be referred to the SPCAA Grievance Procedures for resolution. Copies of such procedures may be obtained from SPCAA upon request.

#### L. Conflict of Interest

To avoid any real or apparent conflict of interest in the procurement of this RFP, no SPCAA employee or their close family member with a relation to a potential broker may vote or evaluate any of the proposals received.

#### M. Subcontracting

The bidder named on the contract must deliver the services of any contract awarded from this RFP. Subcontracting will not be allowed.

#### N. Legal Compliance

The proposer is responsible for full and complete compliance with all the applicable laws, rules, regulations, and licensing requirements imposed by any public/governmental authority having jurisdiction.

#### O. Contract Award

SPCAA will notify the selected bidder via email on or before September 15, 2025. Contract negotiations will commence upon notification.

Failure to submit a complete and executed bid packet may result in the proposal being disqualified from consideration.

#### Scope of Work

Each bidder should address the following areas in narrative format.

#### A. Company Overview and Capacity

This section should describe the proposer's experience and capacity to provide requested services. Please outline recent experience in similar access control system install projects.

This section should also specify the individuals who will be assigned to successfully oversee this project, including their tenure and personal experience on similar projects.

#### **B. Product Features**

This section should provide an overview of the door access system being recommended, including features and user interface functionality.

#### C. Response Time and Availability

This section should detail the bidder's standard response to service calls. This should include average response times, dispatch availability, etc.

#### D. Pricing

This section should detail all cost components of the proposed system implementation. Please break down all costs including one-time software implementation fees, ongoing maintenance and support, recommended costs of hardware/infrastructure repurpose/purchase, and current service call pricing.

#### **Certification of Compliance with Specifications**
