South Plains Community Action Association, Inc. (SPCAA) Head Start Division Request for Proposal for Food Delivery Services

Background Information

South Plains Community Action Association, Inc. (SPCAA) is a 501(c)3 non-profit corporation headquartered in Levelland Texas with main office phone number (806) 894-6104 and website address <https://www.spcaa.org>. SPCAA is a designated Community Action Agency funded in part by the United States Department of Health and Human Services' Community Services Block Grant Program. SPCAA currently administers approximately 64 grant-funded programs in a 126-county area across Texas, including core services in Bailey, Cochran, Crosby, Dickens, Floyd, Garza, Hale, Hockley, King, Lamb, Lubbock, Lynn, Motley, Terry, and Yoakum Counties. SPCAA has a current annual operating budget of approximately \$70 million.

The agency administers grant funded programs in the following program divisions – Head Start/Early Head Start, Community Services, Child Care Services, Health Services, Housing, SPARTAN Transportation, and Workforce.

GENERAL SPECIFICATIONS

A. Request

SPCAA is requesting proposals from qualified sources for food delivery services to its Head Start & Early Head Start facilities. This RFP is being released in accordance with the USDA CACFP guidelines for food purchasing.

The Head Start division of SPCAA operates childcare facilities in Lubbock, Plainview, Brownfield, Denver City, Levelland, Littlefield, Midland, and Post, Texas. SPCAA is seeking a vendor to provide food delivery services to these locations.

A designated SPCAA Head Start employee places orders on a weekly basis. Delivery is expected within 7-10 calendar days to ensure adequate supply at each location. Any anticipated disruption or delay in delivery should be coordinated closely with the designated SPCAA Head Start employee.

B. Purpose

The purpose in soliciting a proposal is to award a vendor an agreement to purchase food delivery items and for services to begin no later than March 1, 2026, and to expire February 28, 2027. SPCAA wishes to include 4 one-year renewal options, through February 28, 2031.

C. Submittal Requirements

The deadline for submission is 12:00 p.m. Central Time, Friday, January 23, 2026. Proposals must be submitted electronically at the email address indicated in the timeline. **Hard copies will not be accepted.**

D. Contact Person

All correspondence regarding the proposal must be submitted via email to Shauna Johnson, SPCAA Head Start Finance Manager, by e-mail at: sjohnson@spcaa.org

E. Agreement Type

The winning proposal will be awarded a standard agreement from SPCAA for food delivery services as specified.

F. Timeline

The successful bidder agrees to begin providing services on or before March 1, 2026.

G. Limitations and Reservations

SPCAA reserves the right to accept or reject any and all proposals received as a result of this request, to negotiate with all qualified sources, or to cancel in part or in its entirety this RFP, if found to be in the best interests of SPCAA.

This RFP does not obligate SPCAA to award a contract, to pay any costs incurred for preparation of proposals or to procure a contract for any services.

SPCAA specifically reserves the right to vary the provision of the agreement any time prior to the execution of the agreement or during the agreed service time where such variance is deemed to be in the best interest of the needs of SPCAA.

If selected for purchasing negotiations, proposer may be required to prepare and submit additional information prior to final purchase execution in order to reach agreeable terms for both SPCAA and the vendor for adequate food delivery services.

H. Modifications and Renewals

SPCAA reserves the right to negotiate a modification or renewal for these services in connection with any executed agreement of funding through this RFP without repeating the RFP process for a period of up to five years from the original agreement initiation.

Agreement modification(s) and/or renewals shall be considered based upon the service provider's ability to meet SPCAA needs.

I. Evaluation Criteria

The selection of a proposal for award is to be made after proposals have been received. Each proposal will be evaluated, on its own merits, for acceptability with emphasis on the various factors enumerated in the Evaluation Worksheet (page 11). The Evaluation Worksheet is provided for your reference and will be used by the SPCAA Independent Evaluation Committee to score the RFP. Each factor is assigned a numerical score. The scores will be used to develop a list of potential service providers with whom negotiations may be conducted. The Evaluation Worksheet is composed of factors relative to the project and assigned points based on their weighted significance as determined by SPCAA. Factors total 100 points. Total evaluation points of less than 60 are grounds to invalidate a proposal.

J. Protest Rights

All protests or complaints regarding this RFP process shall be referred to the SPCAA Grievance Procedures for resolution. Copies of such procedures may be obtained from SPCAA upon request.

K. Conflict of Interest

To avoid any real or apparent conflict of interest in the procurement of this RFP, no SPCAA employee may vote or evaluate any of the proposals received if they or a family member would receive financial benefit from the award.

L. Subcontracting

The bidder named on the awarded agreement must deliver the services of any agreement awarded from this RFP. Subcontracting will not be allowed.

M. Legal Compliance

The proposer is responsible for full and complete compliance with all the applicable laws, rules, regulations, and licensing requirements imposed by any public/governmental authority having jurisdiction.

N. Bid Packet Requirements

Each bid packet should consist of the following items in the order listed:

1. Pricing

See Attachment A for itemized listing of anticipated items purchased. This list is based on current menu and food supply items and is subject to change throughout the agreed delivery period, as menu requirements may change. Bidder should complete pricing information requested and provide any additional price details that may be relevant in the decision-making process.

2. Experience/References

Bidder should describe capacity of its organization, and experience in providing quality food delivery services. Please provide up to 3 (three) references that can support this information.

3. Delivery information

Bidder should provide sample delivery schedule to the locations listed and should itemize fees associated with delivery service. Also, please provide overview of your return policy, and other measures taken to ensure satisfaction with all products.

4. Other

Bidder should provide any other information that may be relevant in the decision-making process:

- a. Is the bidding organization a Historically Underutilized Business, Disadvantaged Business Enterprise, or Minority- or Women- Owned Business, etc.?
- b. Does the bidder offer satisfaction guarantee or return policy on food items?
